### **Background**

The HARICA Public Key Infrastructure (PKI) is a trusted third entity which certifies the identities of network users and servers affiliated with Academic and Research Institutions of the Hellenic Republic.

The HARICA PKI is a consortium between equal members that are Academic Institutions, Research Institutions and the Greek Research and Technology Network (GRNET) which is the Greek National Research and Educational Network (NREN) and began during the VNOC2 project (funded by GRNET through the Operational Program "Information Society"). HARICA is currently funded by the Greek Academic Network (GUNET). This service is available for the members of the Hellenic Academic and Research Institutions.

IT Center of Aristotle University of Thessaloniki (AUTH), which is one of the consortium members, has been appointed as HARICA's operator for all activities which relate to the delivery of its Trust Services. A Policy Management Committee (PMC) with members from both GUNET and AUTH IT Center is responsible for the management, whereas the General Assembly of GUNET, on which AUTH is also represented, holds the high oversight of the HARICA TSP activities.

HARICA has been certified for both ETSI TS 101 456 and ETSI TS 102 042 standards since 2011, it is in the National Trusted Services List (TSL) and it is the only Greek Certification Authority which participates in all Root Programs (Microsoft, Apple, Mozilla).

#### **Assessment Context**

Q-CERT Ltd (distinctive title of "QMSCERT"), as the body carrying out the audit, is accredited by the official Hellenic Accreditation System (ESYD) as conforming to ISO/IEC 17065 (Accreditation Certificate: No.654-3, refer to <a href="http://www.esyd.gr/portal/p/esyd/en/showOrgInfo.jsp?id=17715">http://www.esyd.gr/portal/p/esyd/en/showOrgInfo.jsp?id=17715</a>). Since eIDAS accreditation is not currently offered by ESYD, QMSCERT is in the process of being accredited by the Italian Accreditation System (ACCREDIA). This in accordance with eIDAS Regulation and the ETSI EN 319 403 standard to carry out Trust Service Provider audits. Application has been formally accepted by ACCREDIA at May 4, 2107 with reference number: DC17PRT0413; accreditation office and witness audits have been scheduled for July 2017. #### **Audit Procedure**

Audit Team has been selected on the basis of proficiency and competency in order to prepare and carry out the audit, report its results and submit its recommendation for Technical Review and Certification Decision, according to the established internal procedures of the Certification Body.

Audit was conducted in two phases:

- Documentation review phase, which verified the conformance of documented statements, policies and procedures against the Specifications Context.
- On-site implementation review phase, which verified that all audited policies and procedures (documented or not) were properly implemented into the actual operations of the organization in conformance with the Specifications Context.

Audit took place on sampling basis, under the inherent limitations of the system controls themselves and only in the scope and purpose of the Specifications Context. Its purpose was to verify the conformance of the CA's trust services against the requirements of the eIDAS Regulation and relevant standards.

Internal reports for both stages were documented by the audit team, and its recommendation was submitted for technical review and certification decision, according to the Certification Body's standard procedures and

Initial Examination Period included records from April 27, 2016 to April 26, 2017, but due to the transition to the new ETSI European Norms and eIDAS Regulation, this period was extended until June 9, 2017 in order to include additional records as well.

#### **Audit Results**

### Overview

During technical review, all audit results and internal reports were reviewed, and the TSP was found to be **fully compliant** with the provisions of the Specifications Context. **Improvement remarks** have also been submitted by the Certification Body for review by the TSP, in order to assist its continuous efforts for improvement, in line with the PDCA model. This Certificate and its Annexes (A, B, C) have been issued by the Certification Body in order to officially confirm this assessment.
